We are continuing to operate to and within impacted areas as local conditions and restrictions allow. Due to the dynamic nature of the situation, quoted transit times, and pickup and delivery service availability may be subject to change without notice. No signature required for delivery

Please be assured that we are taking necessary precautions in affected areas as per the guidelines of local authorities. For the safety and wellbeing of our couriers and our customers, our couriers will now only seek a verbal confirmation of delivery. This means that your recipients will not be asked to sign for deliveries, until further notice.

If there is any conflict between the guidelines in this document and the instructions and requirements issued by local authorities or procedures in alignment with recommendations from local authorities, the instructions, requirements and recommendations issued by local authorities or in alignment with local authorities prevail.

COVID-19 Outbreak across Europe

FedEx is adhering to all regulations and guidelines from government authorities related to the containment of COVID-19. These work and travel restrictions may affect shipments inbound and outbound to and from impacted areas, as well as shipments moving within those areas.

We continue to operate inbound and outbound flights to and from impacted areas as local conditions and restrictions allow, and we are taking recommended precautions in terms of team member, subcontractor and customer health and safety.

Despite the potential service delays we may experience due to the COVID-19 outbreak and associated measures imposed by governments around Europe, we are operating to the best of our ability and have adjusted delivery commitments for mainly economy shipments moving by road in certain countries (as noted below). We are using our logistics network to minimize service impacts so we can continue to deliver the best possible service to our customers. Given the reduced capacity available in the market, there will be temporary service adjustments for the following shipments:

In addition, all non-essential shops and services are closed in a number of European countries (including Spain, Poland, France, Germany and Switzerland). We are therefore not able to deliver to any non-essential retail store and customers can no longer deliver to a pick-up point until further notice.

As the COVID-19 outbreak evolves, for the safety and wellbeing of our customers and our couriers, we will no longer ask a recipient to physically sign for most deliveries. There are some limited circumstances in which a signature or some interaction between courier and recipient may still be required, including:

- shipments requiring an adult signature, and
- cash on delivery shipments.

These temporary changes will remain in effect until further notice.

¹Italy specific:

Domestic and International pick-up and delivery services are suspended today, March 20th, in the Orbassano, Alessandria, Bergamo and Brescia areas.

In the Bologna, Como, Milan, Zibido and Vicenza areas, domestic pick-up services are suspended, while deliveries are partially performed.

Due to the restrictions implemented by government authorities, until further notice we are not performing services in the municipalities of Fondi, Polla, Atena Lucana, Sala Consilina, Caggiano, Montebello Jonico, Saline Joniche, San Lucido, Belvedere Marittimo, Diamante, Grisolia, Medicina Ganzanigo.

Domestic pick-up for shipments above 68 kg and non-conveyable shipments are limited across Italy.

Furthermore, the export of Personal Protective Equipment (PPE such as FFP2 masks, goggles or visors, protective suits and gloves) is forbidden to be shipped out of Italy, without prior authorization from the Department of Civil Protection.

²France specific:

Domestic and International pick-up and delivery services are suspended in the Eastern part of France, except for shipments of healthcare and essential food supplies.

Impacted departments include Bas-Rhin (67), Côte-d'Or (21), Doubs (25), Jura (39), Haute-Marne (52), Haut-Rhin (68), Haute-Saône (70), Meuse (55), Moselle (57), Saône-et-Loire (71), and Territoire de Belfort (90).
